KEYWORDS: (Maximum 10 keywords)

54 **INTRODUCTION**

55 In the Introduction section, authors must clearly state the problem(s) being explored in their
56 research study and clarify previous findings in the literature, if applicable. The submission file is
57 in OpenOffice, Microsoft Word, or RTF document file formats.

58 Manuscript text is 12 point, double-spaced, and all Figure legends and Table titles are placed
59 within the text at the appropriate location rather than at the end. The manuscript should be line
60 numbered with continuous marginal line numbers.

66 **METHODS**

67 We highly recommend our authors to consider the following items in the Methodology section:

68 1) The research design must be appropriate for solving the problem(s) stated in the introduction
69 section.

70 2) Authors must provide sufficient information in order for their research to be replicable.

71 Moreover, the method for all forms of data collection must be clearly explained in this section.

72 3) Proper in-text citation and reference (Vancouver style) to previous research work.

73 4) Suitable and reliable equipment and/or software for collecting and analyzing the data.

74 ***Medical Ethics***

75 In research studies involving human subjects, the research protocol must be submitted for
76 consideration, comment, and approval to an appropriate research ethics committee, and must be
77 declared in the manuscript under the methodology sections. At CPOJ we follow the **ICMJE's**
78 [Recommendations for the Conduct, Reporting, Editing and Publication of Scholarly Work in](#)
79 [Medical Journals](#).

80 **RESULTS**

81 In the Results section, authors must report their findings in words, tables, or figures. Presented
82 tables, and figures must be original and comprehensible with informative and appropriate
83 captions. The tables and figures should not duplicate the results provided in text. The **FIGURE**
84 format is in JPEG, TIFF, or PDF and should be uploaded separately. Ensure that each figure has
85 a caption. Keep text in the figures themselves to a minimum, but explain all abbreviations and
86 symbols used.

87 **DISCUSSION**

88 In the Discussion and Conclusion sections, authors must support their findings with intelligible
89 explanations. New findings or results should not be presented in these sections. Moreover, the
90 authors should compare their findings with relevant literature and state their study's limitations
91 at the end of the Discussion section. *“Link the **conclusions** with the goals of the study but avoid*
92 *unqualified statements and conclusions not adequately supported by the data”*.

93 **REFERENCES**

94 Authors must indicate references to the literature by using in-text citations in the “Vancouver”
95 style. References must be listed in numerical order (1,2,3,...), and in the same order in which they
96 are cited in the article. The reference list must appear at the end of the manuscript.

97 **DECLARATION OF CONFLICTING INTERESTS**

98 All authors are required to reveal any financial and personal relationships with organizations or
99 individuals that might have inappropriately influenced their research.

100 **CONFLICT OF INTEREST FORM**

101 At CPOJ, we use the [ICMJE Conflict of Interest form](#). Please download and complete the ICMJE
102 conflict of interest form. The signed form must be submitted along with the manuscript files. All
103 authors are required to reveal any financial and personal relationships with organizations or
104 individuals that might have influenced their research.

105 **CASE STUDY/CASE SERIES**

106 The main body of a single Case study or a Case series should not exceed 2000 words with a limit
107 of 5 figures/tables in total. The main body must include the following sections: Introduction
108 (including case description, assessment, and aim of the study), Methodology, Findings, and
109 Discussion. The Case study or a Case series should have a 200 word limit abstract and should
110 include the following subheadings: Case Description, Aim, Methods, Findings, and Conclusion.
111 Case study/Case series may include up to 5 illustrations (figures or tables).

113 **REVIEW ARTICLE**

114 The main body of a review paper should not exceed 6000 words with a limit of 8 figures/tables
115 in total. The main body must include the following sections: Introduction, Methodology, Results,
116 Discussion, Conclusion, Acknowledgments and References. The abstract has a 200 word limit
117 and should contain the following subheadings: Study design, Introduction, Methodology,
118 Findings, and Conclusions. Formatting (fonts, figure captions, etc.) similar to Research Articles
119 (as stated above) should be followed for Review article.

120 **TECHNICAL/CLINICAL NOTE**

121 Formatting (fonts, figure captions, etc.) similar to Research Articles (as stated above) should be
122 followed for Technical/Clinical notes. The main body of a technical/clinical note should not
123 exceed 1500 words with a limit of 4 figures/tables in total. The main body must include the
124 following sections: Background, Objective, Methodology, Discussion, Acknowledgments, and
125 References. The abstract has a 200 word limit and should contain the following subheadings:
126 Background, Objective, Methodology, and Discussion.
